Instructions to candidates:

1. Candidates will be required to be present in person for the counseling process. Candidates who come after the specified reporting time will lose their original priority as per rank. However, s/he may be offered a seat depending upon the availability of seat at that time. All candidates may note that if admission is not granted on the day of their counseling as indicated in the list, they may be required to present themselves on subsequent day/s, for admission process to be completed.
2. Candidates will be required to bring their following original documents along with self-attested photocopies:
 - Class X Board Examination Certificate
 - Class X Marks-Sheet
 - Class XII Marks-Sheet
 - Class XII Original Certificate
 - Provisional Certificate and Marks-Sheet of the Qualifying Examination
 - Character Certificate (recent, six months)
 - Category Certificate.
 - Migration Certificate: Required for those students who have passed qualifying examination from outside Delhi University
 - At least two passport size self-attested photographs
3. All the CW applicants are required to produce the Educational Concession certificate in the enclosed format to be issued by any of the following authorities on the proper letterhead.
 - (i) Secretary, Kendriya Sainik Board, Delhi.
 - (ii) Secretary, Rajya Zila Sainik Board.
 - (iii) Officer-in-Charge, Record Office.
 - (iv) 1st Class Stipendiary Magistrate.
 - (v) Ministry of Home Affairs (For Police Personnel in receipt of Gallantry Awards)

Admission may be offered to the Children/Widows of Officers and Men of the Armed Forces including Para-Military Personnel, in the following order of preference:

- i. Widows/Wards of Defence personnel killed in action;
- ii. Wards of Defence Personnel disabled in action and **Boarded out** from service with disability attributable to military service;
- iii. Widows/Wards of Defence Personnel who died in peace time with death attributable to military service;
- iv. Wards of Defence Personnel disabled in peace time and **Boarded out** with disability attributable to the military service; and

- v. Wards of serving/ Ex-servicemen personnel including personnel of police forces who are in receipt of Gallantry Awards;
Gallantry Awards include: Param Vir Chakra, Ashok Chakra, Sarvottam Yudh Seva Medal, Maha Vir Chakra, Kirti Chakra, Uttam Yudh Seva Medal, Vir Chakra, Shaurya Chakra, Yudh Seva Medal, Sena, Nau Sena, Vayusena Medal, Mention-in-Despatches, President's Police Medal for Gallantry, Police Medal for Gallantry.

4. No request for the alteration/ adjustment in the day of reporting other than mentioned in the schedule will be entertained.
5. Candidates will be required to complete the admission formalities within 3 working days from the date of counseling, **failing which the offer of admission will automatically stand cancelled and the seat will be offered to the next eligible candidate as per his/her rank.**

6. **PROCESS OF COUNSELING**

- a. Candidates in Category A (Direct admissions category) will be called on the basis of their rank in the merit of graduation scores. Category B candidates (Entrance Test category) will be called on the basis of their rank in the merit of entrance test scores.
- b. At the time of counseling, the candidate will have to specify the category in which s/he is seeking admission (i.e. Category A or Category B). Once the admission choice is exercised, the shifting from one institution to another shall be allowed only in the same category seats. **Thus, the candidate will not be allowed to shift from Category A (Direct Admission) to Category B (Entrance Test) and vice-versa.**
- c. Choice of preference for colleges would be offered as per the available seats on the basis of merit of student in the respective category.
- d. **In case seats under Category A remain vacant due to non-availability of eligible students, the vacant seats shall be converted to Category B.**
- e. Students are required to bring all original documents for verification during counseling. The eligibility condition under various Reserved Categories shall be as provided under University rules.
- f. In the selection of candidates for admission to M.Com course, the decision of the Admission Committee will be final.
